
# **Colington Yacht Club**

#### III. Secretary Report.

The secretary stated there were no changes to Minutes from 5/7/25 and motion to approve was made by Joan Proulx, motion seconded by Tom Knight and all approved by the membership.

### IV. Treasurer's Report

Pat McConnell reported the balance in the CYC checking account is \$6.798.45. Woody and Pat are using a new budget/worksheet report for the club which will distinguish between original budget/revised budget/YTD actual and 2025 projected year end. 2025 Membership Books were distributed at the Poker Run. #### V. Committee Reports

Youth Sailing: Brandi-Marie suggested the CYC make a spare parts bag for our 420 and keep it in the sailing shed. This is something that Jay Phillips requires all of his sailors to prepare and have at all times when sailing. There were questions regarding more details and the purpose and what type of items would be needed. Jay Phillips is now using his new website and Woody has all of the links to send out in the notification to recruit participants for the Sailing Camp. HOA will be asked to send out blasts to the Community. Brandi-Marie states that Lisa said she would be happy to be a speaker for us or at Sail Camp, we will have to call and schedule something but not in the immediate future.

Brandi-Marie informed us that she is too busy with her new business and other personal affairs and wants to let us know she would like someone else to take over Youth Sailing and the Commodore positions. We will not accept her resignation at this time and will work together to get through everything.

**Old Business**: We previously discussed repairs being needed to the Optis and a date was never set. Also, Brandi-Marie had requested an inventory of everything in the Sailing Shed. Brandi-Marie suggested her daughter Eva and her friend go to the shed and make an inventory and to come up with a list of repairs needed for the Optis (if possible). #### Other Events:

<u>Poker Run:</u> Was held on Sunday, May 18<sup>th</sup>, 2025. We had 5 boats to participate and 5 host sites. Subs from Publix were provided by CYC. It was a very windy day but everyone had fun. There were approximately 25 people present, and Ed Conjura was recognized for his service to the club by Tom Knight.

<u>Blessing of the Fleet</u>: This event was held on May 24<sup>th</sup> and approximately 18-20 boats participated. Jack Colena, our neighbor and the Minister from Colington United Methodist Church ministered to our fleet.

<u>Picnic:</u> Date is June 21<sup>st</sup> with Cornhole, Trivia and a picnic at Pavillon. CYC to provide drinks and everyone to provide food for this event. Tom and Janet are unable to be present so Dave, Joan, Woody and Steve Buick will help with the pick-up of food and transporting all of the supplies and beverages to the picnic area. Tom to send out reminder email to all and event will be scheduled for Noon – 5pm.
