
Colington Yacht Club

III. Secretary Report.

V. Committee Reports

Youth Sailing: Janet Knight stated that at our last meeting, Brandi-Marie suggested we make a spare parts bag for our 420 and keep it in the sailing shed. There was discussion regarding items and what we may have plus the expense of some of the items on the list. Rick Hildebrant volunteered to follow up on the items. From our last meeting, Brandi-Marie volunteered her daughter and friend to inventory items in the sail shed and also to check out the Optis for repairs needed. Janet reached out to Brandi-Marie for an update on this with no response. Woody confirmed that he never received any information. Woody stated he is concerned at this time as Jay Phillips reported that only 4-6 kids have signed up for Camp. The HOA will again be asked to send out notifications about sign up for Camp. July 4th was the cutoff for any refunds, but we have not received further updates from Jay Phillips.

Greg Florence is going to get certified for Youth Sailing. He wants his after-retirement job to be Sailing Camps around the area. To continue Youth Sailing by CYC, someone will need to step up and take charge of being responsible for all of the boats and having a camp scheduled.
